Ref: Minutes of the Meeting of the Board of Studies in Ayurveda Course held on 06.09.2016 and approved in the 52nd Meeting of the Standing Academic Board Meeting held on 29.09.2016 and recorded in Resolution No. 32, of the 248th Meeting of the Governing council held on 08.11.2016.

I am to inform that the Meeting of the Board of Studies in Ayurveda Course was held on 06.09.2016 and discussed various academic matters. The decisions of the Board of Studies in Ayurveda Course was approved in the 52nd meeting of the Standing Academic Board, held on 29.09.2016 and recorded in Resolution No:32 in the 248th Meeting of the Governing Council held on 08.11.2016 which are detailed below:

THE RECOMMENDATION AND TO REVIEW THE SYLLABUS OF UG & PG COURSE OF AYURVEDA RECEIVED FROM THE SECRETARY, CENTRAL COUNCIL OF INDIAN MEDICINE, NEW DELHI.

Resolved to approve the following suggestions after reviewing the syllabus of UG & PG course of Ayurveda to CCIM, New Delhi and to seek clarification from CCIM.

- 1. In the existing II year syllabus, the subject, namely, Agad tantra Vyavhar Ayurved evam Vidhi Vaidyaka (Toxicology and Medical Jurisprudence) can be shifted to III year and a subject, namely Roga Nidan Vikriti Vigyam (Pathology & Microbiology) can be shifted to II year BAMS.
- 2. In the existing syllabus of IV year, subject namely Kaya Chikitsa can be made in to three papers instead of existing two papers with the detailed Ayurveda related syllabus.
- 3. It was resolved to request the CCIM to reduce the practical marks to 150 (practical & viva-voce) :(100+50) instead of 200 in respect of the II year subjects (i) Dravya Guna (ii) Rasashastra and Bhaishajya Kalpana.

THE INCLUSION OF NSS AS AN ELECTIVE SUBJECT IN THE CURRICULUM OF MEDICAL, DENTAL, NURSING, PHARMACY, INDIAN MEDICINE, HOMOEOPATHY AND ALLIED HEALTH SCIENCE COURSES.

Resolved to write to the CCIM, New Delhi to include the following topics of NSS as an elective subject in the third year subject i.e. Swasthavritha of UG BAMS curriculum.
