The following recommendations of the Standing Academic Board was approved by the Governing Council at the 291st meeting held on 09.06.2022. The Standing Academic Board has resolved that

POINTS

- To implement the Compulsory Rotating Medical Internship Regulations, 2021 published by National Medical Commission in the Notification dated 18-11-2021. (Published in the University website)
- To follow the National Medical Commission regulations for Competency Based Curriculum of Final MBBS Part I and Part II pertaining to Syllabus, teaching hours, Formative Assessment, Summative Assessment, Eligibility criteria for appearing for examination, Pattern of Question paper in the University examination, conduct of examinations and pass criteria.

- To conduct a minimum of eight internal assessment (both theory and Clinical/Practical) spread over the curriculum in each of the clinical subject for which there are University examinations in Final MBBS Part I and II. Within the ambit of the main subject, IA test in disciplines included there of, may be worked out by the HOD's concerned and the Head of the Institution and average of eight assessment tests will be taken as final IA marks.
- Uniform pattern of Academic Record (Log Book) prepared and circulated to the affiliated institutions by the university. This log book must contain all the academic activities carried out by the student along with assessment. (Published in the University website)
- To implement the Circular No.U/11026/1/2022/-UGMEB dated 31st March 2022 from National Medical Commission with regard to Implementation of new Competency Based Medical Education for Undergraduate Course Curriculum & Amalgamation of old and new batch of MBBS students in the new CBME Course Curriculum.
