## <u>Instructions to Apply for Online Issue of Eligibility Certificate</u>

- Candidates who have passed qualifying examination from the following boards need not apply for Eligibility Certificate from this University.
  - Higher Secondary Examination (+2) conducted by State Board of School Examinations, Tamil Nadu.
  - Central Board of Secondary Education (CBSE) CBSE Schools in Tamil Nadu, CBSE Schools in other States of India and CBSE Schools outside India.
  - Council for the Indian School Certificate Examinations (CISCE) -ISC Schools in Tamil Nadu, ISC Schools in other States of India and ISC Schools outside India.
- The Eligibility Certificate will not be issued in person.
- Issue of Eligibility Certificate is ONLY by Online Mode.
- Please use Desktop/Laptop and avoid mobile phones to apply.
- Please use only the registered mail id for all communications related to Eligibility Certificate.
- Please upload clear & visible Documents (70 kb 150 kb per document).
- Please check the filled in application before submission.

#### NOTE:

- Medical Single Eligibility Certificate for MBBS, BDS, BSMS, BUMS, BHMS, BAMS, BNYS.
- Only BNYS (Candidates applying only for BNYS and not applying for any of the other courses in the Medical category shall select 'Only BNYS')
- **Paramedical** Single Eligibility Certificate for Nursing, Pharmacy, Physiotherapy, Occupational Therapy & Allied Health Sciences U.G. Courses.

Following candidates shall obtain Eligibility Certificate from the Tamil Nadu Dr. M.G.R. Medical University for admission to Undergraduate degree courses in the affiliated Institutions of this University.

- Candidates who have passed any qualifying examination other than the Higher Secondary Examination conducted by the Government of Tamil Nadu / +2 examination from the Central Board of Secondary Education (CBSE) in the state of Tamil Nadu, Other States and Outside India / Indian School Certificate Examination (ISC) in the State of Tamil Nadu / Other states in India and ISC Schools outside India.
- 2. Candidates who have passed +2 / Higher Secondary Examination/ other qualifying examinations from States outside Tamil Nadu.
- 3. Non Resident Indian (NRI) candidates.
- 4. Foreign Nationals.
- 5. Indian Candidates who have studied Abroad other than CBSE/ISC Schools.

## Submission of Application through ONLINE mode only:

Candidate has to fill the Application Form through the ONLINE PORTAL of The Tamil Nadu Dr. M.G.R. Medical University <a href="https://www.tnmgrmu.ac.in">www.tnmgrmu.ac.in</a>.

Application in Hard copy / Application received through e-mail will not be entertained.

# <u>Documents to be uploaded and fees to be remitted:</u> <u>For candidates in Sl. No. 1 & 2</u>

- I. Candidate has to upload the self attested scanned copies of the following documents for issue of Eligibility Certificate.
  - a) Statement of Marks of Higher Secondary School Certificate Examination (+2 Course or Equivalent Examination).
  - b) Proof for Date of Birth (Birth certificate /Transfer Certificate/10th Standard mark Sheet / Aadhaar card.)
  - c) +2 Migration Certificate.
  - d) NEET score card for MBBS, BDS, and AYUSH (other than BNYS).
  - e) Community certificate (other than OC).

#### II. Fee particulars:

- a) Candidates applying for Medical Degree courses (MBBS, BDS, AYUSH) have to remit a sum of INR 1,400/- + INR 252/- (18% GST amount) totalling to INR 1,652/- towards the fee for issue of Eligibility Certificate.
- b) Candidates applying for Paramedical Degree courses have to remit a sum of INR 1,200/- + INR 216/- (18% GST amount) totalling to INR 1,416/- towards the fee for issue of Eligibility Certificate.

## <u>Documents to be uploaded and fees to be remitted:</u> <u>For candidates in SI. No. 3</u>

- I. Candidate has to upload the self attested scanned copies of the following documents for issue of Eligibility Certificate.
  - a) Statement of Marks / Grade of Advanced level or any other equivalent examination.
  - b) Equivalency Certificate from Association of Indian Universities, New Delhi for study in Boards not established in India (Foreign Boards).
  - c) Proof for Date of Birth (Birth certificate, Transfer Certificate, 10th Standard mark Sheet / Aadhaar card etc.)
  - d) +2 Migration Certificate / No Objection Certificate from the School or University last studied.
  - e) NEET Score card for MBBS, BDS, AYUSH (other than BNYS).
  - f) Valid Passport.

# Documents to be uploaded and fees to be remitted: For candidates in Sl. No. 4

- q) Valid Visa.

  - b) Equivalency Certificate from Association of Indian Universities, New Delhi for study in Boards not established in India (Foreign Boards).
  - c) Proof for Date of Birth (Birth certificate, Transfer Certificate, 10th Standard mark Sheet / Aadhaar card etc.)
  - d) +2 Migration Certificate / No Objection Certificate from the School or University last studied.
  - e) NEET Score card for MBBS, BDS, AYUSH (other than BNYS).
  - f) Valid Passport.

In continuation of the recommendations of Finance Committee and the resolution of 292nd meeting of the Governing Council, the following will be the fee structure for Eligibility Certificate for the various categories:

## For NRI CANDIDATES:

#### The Fee

- for Eligibility Certificate for admission to UG Medical and Dental courses will be INR 31,000/-
- for EC for admission to PG Medical or PG Dental courses will be INR 31.000/-
- for EC for admission to UG courses in AYUSH, Pharmacy, Nursing, Physiotherapy, Occupational Therapy and AHS will be INR 26,000/-
- for EC for admission to any of the PG courses in AYUSH, Pharmacy, Nursing, Physiotherapy, Occupational Therapy and AHS will be INR 26,000/-

## **For FOREIGN NATIONALS:**

#### The Fee

- for EC for admission to UG Medical and Dental courses will be INR 49,000/-
- for EC for admission to PG Medical or PG Dental courses will be INR 49,000/-
- for EC for admission to UG courses in AYUSH, Pharmacy, Nursing, Physiotherapy, Occupational Therapy and AHS will be INR 40,000/-
- for EC for admission to any of the PG courses in AYUSH, Pharmacy, Nursing, Physiotherapy, Occupational Therapy and AHS will be INR 40,000/-

## For INDIAN CANDIDATES WHO HAVE STUDIED ABROAD:

## The Fee

- for EC for admission to UG Medical and Dental courses for Indian candidates who have studied their eligibility course abroad (Other than candidates who have studied in CBSE & ISC Schools) will be INR 26,000/-
- for EC for admission to PG Medical or PG Dental courses for Indian candidates who have studied their UG degrees abroad will be INR 26,000/-
- for EC for admission to UG courses in AYUSH, Pharmacy, Nursing, Physiotherapy, Occupational Therapy and AHS for Indian candidates who have studied their eligibility course abroad (Other than candidates who have studied in CBSE & ISC Schools) will be INR 26,000/-
- for EC for admission to any of the PG courses in AHS for Indian candidates who have studied their eligibility course abroad will be INR 26,000/-
