INCREASE OF SEATS OF MD/MS POST GRADUATE DEGREE COURSES**

Receipt of Applications for the starting / increase of seats in MD/MS Post Graduate Degree course	1 st June to 31 st July* Note: <u>To start / increase of seats in MD/MS courses in 2021-2022, applications will be received till 31st August 2019.</u> Applications received after 31 st August 2019 will not be considered for the starting / increase of seats in the said courses in 2021-2022.
2.	Technical Scrutiny and Assessment Inspections	1 st August to 31 st September
3.	Receipt of Compliance Reports/Replies from the applicant Institutions	1 st October to 31 st October
4.	Scrutiny of Compliance Reports & Perusal	Till 15 th February
5.	Notification of Rejection of any application	15 th February
6.	Issue of Letter of Consent of Affiliation to Eligible Institutions	28 th February

* To start the course in the academic year 2022-2023, the filled in applications and appropriate valid enclosures should reach the University between 1st June 2020 and 31st July 2020.

MD / MS PG Degree Course

- 1) Starting of new course - FORM – A / increase of seats – FORM- D (Application for Letter of Consent of Affiliation).
- 2) Evidence to show that the College / Institution / Hospital has been in existence in that speciality.
- 3) **For the Starting of Pre and Para Clinical Courses:**

Copy of III year Renewal of Permission i.e . along with the admission of fourth batch of MBBS degree course from the Medical Council of India / Government of India, Ministry of Health & Family Welfare, New Delhi.

- 4) **For Starting of Other Specialities:**

The Medical College / Institution must be recognized by the Medical Council of India / Government of India, Ministry of Health & Family Welfare, New Delhi for conducting MBBS degree course / Post Graduate Degree course.

- 5) **Fee details:-**

- i) Application fees for starting of New course : Rs.14,160/- (Rs.12,000/-+ GST18% Rs. 2,160),
- ii) Application fees for increase of seats in existing speciality : Rs.2,360/- (Rs.2,000/-+ GST18% Rs.360),
- iii) Letter of Consent of Affiliation Processing Fees of Rs.82,600/- (70,000/- + GST18% Rs.12,600).
- iv) Inspection Fee of Rs.59,000/-(50,000/- + GST18% 9,000)

- 6) Fees amount shall be remitted through RTGS / NEFT online remittance system and submit the proof of remittance along with 1), 2), 3) and 4).

NOTE:

- Only the Education Trust / Societies / Organization as defined in the Medical Council of India Regulation shall be eligible to apply for Letter of Consent of Affiliation.
- Application from individuals for Letter of Consent of Affiliation shall not be entertained.
- **Belated submission of application for obtaining Letter of Consent of Affiliation for starting of new course / for increasing seats will not be considered. Piecemeal Application and application received after the Last date will be summarily rejected.**
