REQUIREMENT OF DOCUMENTS / FEES FOR GRANT OF PROVISIONAL AFFILIATION (PA) TO START NEW INDIAN MEDICINE & HOMEOPATHY COURSES AND PERMISSION ORDER FOR INCREASE OF SEATS.

1. Application Form along with copy of Letter of Consent of Affiliation and Letter of Permission from the Department of AYUSH, New Delhi

2. Fee: UG Indian Medicine & Homoeopathy Course

(a) Cost of Application Fee : Rs. 2,000/- + 18% GST with Form-III (available in Statutes)

(b) Inspection Fee : Rs.50,000/- + 18% GST

(c) University Administrative Expenses Fee (for 50 intake) * (UAE) : Rs. 40,000/- + 18% GST [(10% of respective fee for every 10 students) (i.e.) (Rs.40,000/- x 10% = Rs.4,000/-)]

(d) Provisional Affiliation Fee (for 50 intake) * : Rs. 3,00,000/- + 18% GST [(10% of respective fee for every 10 students) i.e.) (Rs.3,00,000/- x 10% = Rs.30,000/-)]

(e) Security Deposit : Rs.20,00,000/-
