
With reference to your letter No. ACII (1)/60583/2011 dated 26.12.2011 on the subject cited above, I am to inform you that the matter has received the attention of this Council and its P.G. Education Committee and Education Committee in their respective meetings held on 21.3.2012, 20.03.2012 and 03.01.2012. Their decisions are reproduced below:-

The P.G. Education Committee considered the matter and it recommended that it has no objection in respect of proposals of the University so far as M.D. (Hom.) courses are concerned as the same do not contravene Homoeopathy (Post Graduate Degree Course) regulations (as amended upto 2001).

The Education Committee discussed the matter at length and decided that under the provisions of Homoeopathy Central Council Act, 1973, the Central Council has prescribed the minimum norms which can not be diluted. However, if the University intends to improve these minimum norms for betterment of the standards of education in Homoeopathy C.C.H. will have no objection provided the internal assessment is not included within the marks prescribed in Homoeopathy (Degree Course) Regulations (as amended till 2005).

The Central Council ratified the decisions taken by the P.G. Education Committee and Education Committee in the matter.
