Number of seats	: Sixteen (16)
Duration	: Two years – Full time Course
Timings	: Full Time – Regular Course

Course Objectives

On completion of MSc (PH) course, candidate as a public health professional should be able to:

- Identify and prioritize key public health issues.
- Understand the principles involved in the management of health service organizations and in planning the development of health services
- Conduct critical assessment in specific domains of public health
- Do research in accordance with ethical principles relevant to public health work.

Partnership with Health Systems



The proposed programme would tie-up with Directorate of Public Health and Preventive Medicine (DPHPM) and its extended facilities. At the DPHPM the students will have an exposure to public health programmes that include National Health Mission, disease control/surveillance programmes. The extended facilities include Institute of Public Health [IPH] (Poonamallee) /Institute of Vector Control and Zoonosis (Hosur) and all the Public Health training institutes across the State would be utilised as appropriate. The programme will have partnership with medical colleges and its clinic facilities.

Format of the Course

Year 1: Candidates will spend the first six months at DoE -The Tamil Nadu Dr. M.G.R. Medical University, Chennai/ collaborating institutes of DPH&PM undergoing first semester training in core courses and would be involved in developing a project application based on their electives for their

field training. They would be involved in In-Field project/research programmes upon written approval by the on- and off-campus supervisors/guide for the next 4 months (7th to 10th month). During 11th month they would return to DoE & submit the In-Field project Report and take first semester examinations.

Year 2: Candidates will spend the first three months at DoE undergoing second semester training in core course and would be involved in developing a protocol for their Capstone Project/ Thesis based on their elective topic. During the next 4 months (16th to 19th month) they work on data collection, data entry, analysis for their thesis (with an approved e- field movement plan & maintaining log book). Subsequently, candidates will return to the DoE to write the second semester examinations as well to finalise thesis work. The candidate will submit a proof of manuscript submission for publication to a peer-reviewed, index journal & defend their Thesis in a viva-voce examination at 24th month.

Eligibility & Admission requirements

The following represent the standard minimum undergraduate degree requirements for admission to the MSc (PH) program:

- Bachelor of Science in Life sciences (including Food Tech, Dairy), Statistics, Nutrition, Social work, Communications or equivalent* from a recognised University acquired as a full-time student
- Bachelor degree in health or health-related programs such as Medicine (MBBS), Dentistry (BDS), AYUSH (BAMS, BUMS, BSMS, BNYS, BHMS), Veterinary, Nursing, Physio/Occupational Therapy and Pharmacy, Bachelor in Engineering (Civil)

*Work experience in a health-related field is desirable.

Thus, widening of above eligibility would facilitate inter-disciplinary curriculum based on electives & make pathways of public health action as multi-sectoral.

Selection Policy

- Selection will be based on written entrance examination and an interview to be conducted to all the eligible candidates. The final selection will be made after interview.
- The candidate understanding of basic human biology and disease process and capacity to comprehend quantitative information, past academic performance, past experience and confidential reports from referees will be taken into consideration wherever necessary.
- Successful candidates will be provisionally selected for admission to the two years M.Sc. (Public Health) Degree course.
- Decision of the University/Selection committee will be final.

At the time of interview/admission, the following certificates should be made available in original for verification.

- Mark / Grade sheets of qualifying degree
- Provisional Pass Certificate
- Degree certificate of qualifying degree
- Transfer certificate from the institution last studied
- Migration certificate (if applicable)
- Permanent Registration certificate from respective councils (if applicable)
- Eligibility Certificate for admission to M.Sc.(Public Health) course obtained from The Tamil Nadu Dr.M.G.R. Medical University (for candidates from other universities)
- Service certificate issued by the Head of the Office in respect of the service candidates
- Certificate for Physical fitness by an authorized Medical Officer (at the time of admission).

Last date for joining the course

Those finally selected and medically cleared for admission will be required to join the M.Sc.(Public Health) course on or before 31.10.2023 (Tuesday) before 05.45 PM after paying the tuition fee and other fee for the first year of the course as mentioned.

Course fee and Examination fee for First Year and Second Year:

Candidates are instructed to get fees details from the Department of Epidemiology

Mode of payment of fees

- Tuition fees should be paid through online gateway method.
- The University reserves the right to revise the tuition fee/exam fee from time to time.
- All fees once paid will not be refunded under any circumstances.

If any candidate discontinues the course after one month of joining, is liable to pay the second year fees also before his / her relief / receipt of his / her original certificates.

Eligibility for the degree

Candidates will be eligible for the Master of Degree in Public Health if they fulfil the following requirements;

- a) Pass in the written, practical and oral examination to be conducted at the end of the 1st year.
- b) Submission and satisfactory defense of a thesis/dissertation produced following bonafide work of

the candidate at the end of the 2^{nd} year.

Duration

The duration of the M.Sc. (Public Health) course is two years and the students should complete the course in 4 years of time, failing which he/she will be discharged from the course.

Eligibility certificate

The candidate, who has passed any qualifying examination other than the Tamil Nadu Dr. MGR Medical University, shall obtain an "Eligibility Certificate" from this University by remitting the prescribed fee along with the application form and required documents before seeking admission to anyone of the affiliated medical institutions. The application form is available in the University website (www.tnmgrmu.ac.in).

Attendance / Internal Assessment Marks required for admission to examinations

• No candidate shall be permitted to appear in any one of the parts of M.Sc. (Public Health) course in Examinations unless he/she has attended the course in all the subjects for the prescribed period in as per the regulations of the University.

- Each candidate must produce the necessary certificate of attendance and internal assessment marks (IA) and satisfactory conduct from the Head of the institution to qualify for the examination.
- A candidate is required to put in the minimum required attendance both theory and practical separately in each subject before admission to the Examinations.
- A candidate lacking in the prescribed attendance / internal assessment marks (IA) in any one subject in theory and practical wherever necessary in the first appearance shall not be permitted for admission to the entire examinations.

Condonation of Lack of Attendance

There shall be no condonation of lack of attendance.

Examinations:

There shall be two examinations, one at the end of the I year and the other at the end of the II year. A candidate will be permitted to appear in second year examinations, only if he/she passes the first year subjects. The date(s) of examinations will be as per the university exam schedule.

Dissertation

- Dissertation shall be submitted by the candidate three months before the final and second year examinations.
- If the candidate fails in the Written/Practical examination, but his/her dissertation is approved (passed), the approval of the dissertation shall be carried over to the subsequent examination.
- Two copies of the evaluation report of the dissertation will be submitted by the Examiners to the Controller of Examinations of this University.

A candidate failing in either theory or practicals will have to reappear for theory, practical's and Viva voce to be able to clear the examination in subsequent attempt. However, the dissertation, if approved (passed), need not be submitted again.
