I am to inform that the Meeting of the Board of Studies in Unani Course was held on 29.06.2015 and discussed various academic matters. The decisions of the Board of Studies in Unani Course was resolved by the 50<sup>th</sup> meeting of the Standing Academic Board, held on 23.07.2015 and passed in the 238<sup>th</sup> Meeting of the Governing Council held on 13.08.2015 which are detailed below:

#### **APPOINTMENT OF EXTERNAL EXAMINERS FOR PAPER VALUATION:**

It was resolved to appoint separate external examiners for conducting practical examinations and for paper valuation. The Chairman has agreed to provide the list of examiners to the Controller of Examinations / Course i/c.

#### **UNANI TEXT BOOKS IN THE UNIVERSITY LIBRARY:**

It was resolved to keep a set of Unani Text books in the Library for reference while moderating the Question papers, for paper valuation and for the use of students. The list of books will be sent by the Chairman to the Librarian along with the Publishers list.

#### **INCORPORATION THE ENGLISH EQUIVALENT TERMINOLOGY**

It was resolved to incorporate the English equivalent terminology along with names of subjects in the mark list as per MSR Regulations 2013. This may be implemented for the students admitted from the Academic year 2015-16 onwards.

**INCLUSION OF ONE MORE CLAUSE IN THE EXISTING REGULATIONS FOR CONDONATION OF BREAK OF STUDY FOR UNDER GRADUATE AND POST GRADUATE DEGREE COURSES OF THIS UNIVERSITY.**

Resolved to approve the inclusion of one more clause in the existing Regulations for condonation of Break of study for Under graduate and Post graduate degree courses of this University as follows:

<b>Existing regulation under serial .No.7 of under graduate course and under serial No.5 of post graduate course</b>	<b>To add under Serial No.7 as sub serial (a) for undergraduate course and under serial no.5 as sub serial (a) of Post graduate course</b>
If any candidate complete the course of study and appeared for Final Year Examination but failed in one or more subjects and consecutively does not appear for two supplementary Examinations shall undergo Refresher Course for a period of Six months from the Institution in which the candidates has last studied”.	The candidates who have completed the course of study but not appeared for the University Examination consecutively for more than two sessions, shall undergo a Refresher Course for a period of Six Months in the same Institution in which he/she has last studied.”

Resolved to display the rules and regulations prescribed for break of study prominently in the university website and to send a circular informing the break of study rules / regulations to all affiliated colleges.

This will be implemented from the academic year 2015-16 onwards.

I am to request that the decision of the Standing Academic Board as mentioned above may be communicated to all the Professors and Heads of Departments for information and further follow up action in the regard.
