**POINT NO:1**

**U.G.REGULATION PRESCRIBED BY THE CENTRAL COUNCIL OF INDIAN  
MEDICINE, NEW DELHI TO BE IMPLEMENTED FROM 7TH NOVEMBER 2016  
BASED ON THE GAZETTE NOTIFICATION FOR BAMS DEGREE COURSE.**

It was **resolved** to follow the U.G. Regulation prescribed by the Central  
Council of India Medicine, New Delhi and implemented the same from the  
academic year 2016-2017 admission onwards as there is no change in the first  
year subjects.

## **POINT NO:2**

### **SUGGESTIONS WITH REGARD TO CURRICULUM OF BAMS DEGREE COURSE.**

It was **resolved** to approve the following:-

1.To Maintain uniform Common Log book by all Ayurveda Medical Colleges. (Common Log book format has to be framed and submitted to the University by the members of the Board of Studies)

2. Common Academic Calendar for all Ayurveda Medical Colleges:

a). To obtain clarification from the Central Council of Indian Medicine regarding cut off date of admission for Under Graduate course in BAMS.

b) To conduct formative assessment tests by the respective institutions.

## **POINT NO:3**

### **NOTIFICATION RECEIVED FROM THE CENTRAL COUNCIL OF INDIAN MEDICINE, NEW DELHI FOR BOTH MD/MS – AYURVEDA DEGREE COURSE**

It was **resolved** to follow the notification received from the Central Council of Indian Medicine, New Delhi for both MD/MS – Ayurveda Degree course and to implement the same from the academic year 2017-2018 admission onwards.

## **POINT NO:4**

### **MINIMUM EXPERIENCE REQUIRED FOR THE FACULTIES OF UG DEGREE COURSE IN AYURVEDA TO APPOINT THEM AS PAPER VALUATOR, MODERATOR, ORAL/PRACTICAL EXAMINER AND QUESTION PAPER SETTER.**

It was **resolved** to approve the minimum experience/ qualification required to be a Paper valuator, Moderator, Oral/Practical Examiner and question paper setter for the University examinations for UG course shall be of **three years** teaching experience in the concerned subject.

## **POINT NO:5**

**COPY OF THE LETTERS F.No.R-13040/33/2016-HD (Tech) Part DATED 08-11-2016 REGARDING ADMISSIONS IN INDIAN MEDICINE COURSES IN THE COUNTRY THROUGH NATIONAL ELIGIBILITY CUM ENTRANCE TEST (NEET) ONLY FROM THE SESSION 2017-18 FROM THE ASST.SECRETARY (TECH.) CENTRAL COUNCIL OF HOMOEOPATHY, NEW DELHI VIDE Lr.No.14-6/2016-CCH(Pt.)/22982-23241 DATED 18.11.2016.**

As per the communication from Ministry of AYUSH F.No.R-13040/33/2016-HD (tech) Part dt 26.04.2017, the admission in AYUSH UG courses shall be compulsorily through NEET merit list from the academic year 2018-19 and hence this will be implemented for the UG candidates admitted from the academic year 2018-19.
