I am to inform that the meeting of the Board of Studies in Final MBBS (Phase I and II) was held on 12.08.2020 and discussed various academic matters. The recommendations of the Board of Studies in Final MBBS (Phase I and II) was approved by the 59th Meeting of Standing Academic Board held on 16.09.2020 and passed in the 277th meeting of the Governing Council held on 30.09.2020 which are detailed below:

(I) Regarding on the request of the interns to condone the delay in commencement of internship in time, due to COVID-19 lock down.

The Board has resolved

i) to condone the delay in commencement of internship in time, due to COVID 19 Pandemic situation and lock down from 22nd March 2020 to till normal situation. This is given as one time measure and cannot be quoted as precedence.

ii) this is applicable to candidates who had passed Final MBBS Examinations held in February 2020 and also

iii) the Dean of the respective Institutions shall condone the delay in commencement of internship (from 22nd March 2020 till return of Normalcy) and shall forward the list to

the University.

iv) to extend the internship period proportionately so as to complete the prescribed period of internship.

(II) Regarding examination, the Board has resolved to follow the advisory issued by Medical Council of India as one-time measure with regard to conduct of examination for all under graduate courses and also resolved to make modifications in subsequent examination if required.

I am to request that the above decision of the Standing Academic Board may be communicated to all the Professors and Head of Departments for information and for further follow up action in this regard. I am also request that a copy of this letter shall be displayed on the Notice Board of the College/Hostel for information of the Student community.
