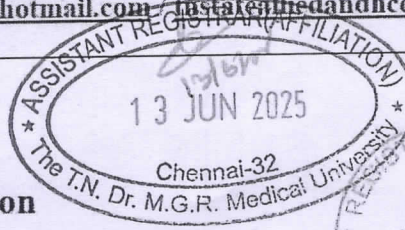

- i. Establishment of new Allied and Healthcare Institution with specific courses and intake capacity;
  - ii. Increase in intake capacity in existing courses from existing Allied and Healthcare Institute; and
  - iii. Addition of new courses in existing Allied and Healthcare Institutes.  
**until requisite Regulations are framed and notified by NCAHP under Section 66 of the NCAHP Act, 2021.**
2. You are, therefore, requested to immediately communicate this directive to **all Universities, Colleges and Institutions** affiliated or intending to affiliate under the Allied and Healthcare domain in your respective State/UT and ensure **strict**

**compliance** with the above-mentioned Order dated 09.12.2024 (**enclosed**). Non-adherence will be viewed seriously and may invite appropriate action as per provisions of the Act.
