

Eligibility for the appointment of Distinguished Professor and Responsibilities of Distinguished Professor

1 Eligibility

- Retired Professors of Government / Private institutions affiliated to this University are eligible to apply for the position of Distinguished Professor. There is no age restriction.

2 Procedure to apply:

- Eligible faculty members shall apply in writing
- Applications for Distinguished Professorship should be addressed to the Vice Chancellor.

3 Appointment

- After scrutiny, the letter of appointment shall be issued.
- The appointment shall come into effect from the date of issue of appointment letter
- The right of appointment of Distinguished professorship rests with the Vice Chancellor of the University

4 Tenure:

- The tenure of appointment of Distinguished Professorship shall be for 3 years from the date of appointment.

5 Honorary Appointment

- The appointment is purely Honorary and hence the Distinguished Professor shall not be eligible for any remuneration from the University of his / her service.

6 Other Conditions

- When a Distinguished Professor decides to settle permanently outside India the same may be informed to the University with a written request of withdrawal of Distinguished Professorship voluntarily.
- Every Distinguished Professor shall send an annual report of his / her academic performances to this University.
- The appointment is vested with a moral responsibility of submitting the annual report as a gesture facilitating harmonized rapport between the University and the Distinguished Professor.
- After appointment of the University is entitled to utilize the rich academic expertise of the Distinguished Professor in its research Programmes and such other related

academic activities.

- All the Distinguished Professor of this University, administratively shall be under the control of the Vice Chancellor of this University and academically the shall co-ordinate with the Dean of Students of this University.
- The Distinguished Professor shall intimate the change of contact address, contact numbers and email addresses from time to time for better and effective communication.

7 Responsibilities of the Distinguished Professor

The Distinguished Professor shall engage themselves in lectures, as an opportunity for dissemination of knowledge in their speciality in affiliated Govt/ Private Medical Colleges at the place of their location.

Lecture in this respect apart from taking classes in a Medical College, shall also include effective participation in CME Programme Symposia, Seminars, Workshops etc.,

The schedule may be fixed in co-ordination with the concerned head of the Department / Institution.

The Distinguished Professor shall send an annual report of the performances along with suggestions, if any, in the form of annual report every year to this University.

The Distinguished Professor shall take voluntary initiatives to share his / her expertise and disseminate knowledge to medical fraternity and common public.

The Distinguished Professor shall also take steps to co-ordinate with the University, in matters of academic collaboration with other Universities with in India and abroad.

The Dean of Students of this University shall co-ordinate with the academic activities of each Distinguished Professor and shall keep track of the programmes that are conducted by the Distinguished Professor

**GUIDELINES AND ELIGIBILITY FOR HONORARY
PROFESSORSHIP – EMERITUS PROFESSOR**

This appointment is purely on honorary basis.

The Age Limit should be above 58 years. The person should be with good health and sound mind After retirement he/she should have not been reappointed either in Government or working in a Deemed University while applying for this Professorship and for the entire tenure of Emeritus Professorship. He / She should be Retired Professors in the Medical / Dental field in Government / Private Institution affiliated to this University or any National / International University.

The tenure is fixed for a period of 03 years.

The Professor needs to publish at least two papers in indexed National / International journals in their own specialty.

He / She should intimate the University regarding the withdrawal, in case he / she decides to settle abroad permanently. He/ She needs to inform the University, if he / she leaves abroad even for a short trip.

His / Her expertise should be utilized in the respective field through academic activities and yearly report needs to be submitted to the University.

Total Number of Professors shall not exceed 100.

He / She should not hold any post in any college/ University as a full time teacher during his/her professorship of this University.

They are not eligible for any remuneration from the University for their services.

They are not entitled to use the University Emblem for any other purposes.

They should not use the prefix “Professor” merely based on this conferred Professorship rendered by this University.

If he/she is found to be guilty of Professional/ Misconduct, he/she may be removed from the Professorship List.

The appointment / Removal is at the discretion of the Vice-Chancellor.

Extension of one more Term may be considered by the Vice-Chancellor.

GUIDELINES, DUTIES AND RESPONSIBILITIES OF ADJUNCT PROFESSOR

This appointment is purely on honorary basis.

They should be Professors in the Medical / Dental field in colleges affiliated to the University or an Expert of Repute working / functioning in Tamilnadu.

There is no age restriction. The person should be with good health and sound mind and merit.

The tenure is fixed for a period of 3 years.

The Professor needs to publish at least two papers in indexed National /International journals in their own speciality.

He/ She should intimate the University regarding the withdrawal, in case he / she decides to settle abroad permanently. He / She needs to inform the University, if he / she leaves abroad even for a short trip.

His / Her expertise should be utilized in the respective field through academic activities and half- yearly report needs to be submitted to the University.

Total Number of Professors shall not exceed 100.

They are not eligible for any remuneration from the University for their services.

They are not entitled to use the University Emblem for any other purposes.

If he/she is found to be guilty of Professional/ Misconduct, he/she may be removed from the Professorship List.

Adjunct Professors of this University should not use the prefix "Professor" merely based on this conferred professorship rendered by this University.

The appointment / Removal is at the discretion of the Vice-Chancellor.
Extension of one more Term may be considered by the Vice-Chancellor.

GUIDELINES AND ELIGIBILITY FOR HONORARY PROFESSORSHIP
VISITING PROFESSOR (National & International)

This appointment is purely on honorary basis.

There is no age limit. The person should be with good health and sound mind and merit.

The tenure is fixed for a period of 3 years.

The Professor needs to publish at least two papers in indexed National International journals in their own specialty.

The applicants should be a Professor in the respective Medical Field in any International University.

His/Her expertise should be utilized in the respective field through academic activities and half- yearly report needs to be submitted to the University.

Total Number of Professors shall not exceed 100.

They are not eligible for any remuneration from the University for their services.

They are not entitled to use the University Emblem for any other purposes.

They should not use the prefix "Professor" merely based on this conferred Professorship rendered by this University.

If he/she is found to be guilty of Professional/ Misconduct, he/she may be removed from the Professorship List.

The appointment / Removal is at the discretion of the Vice-Chancellor.

Extension of one more Term may be considered by the Vice-Chancellor.
