REGULATIONS FOR THE
CANDIDATES WHO HAVE CROSSED
DOUBLE THE DURATION OF COURSE OF STUDY
AND DISCHARGED FROM THE COURSE.

Existing:

The duration of M.B.B.S Course is $5\frac{1}{2}$ years consist of $4\frac{1}{2}$ years study period and one year internship. It was found from the records that some of the candidates have not completed the course within the above stipulated period. They have not completed the course even after surpassing double the duration of the course (i.e) within eleven years (11 years). Those candidates who have not completed the course within double the duration cannot be allowed to write the examinations and practice as Doctors after a long gap, as the Under Graduate Medical subjects deal with human lives.

Initiatives of the University:

It has, therefore, become necessary to regulate such of those candidates who have not completed the course either in U.G or P.G within double the duration. The Medical University has decided to frame Regulations for the candidates who have crossed double the duration.

The Regulations framed by this University for the candidates who have crossed double the duration of the respective course of study is appended hereunder.

**REGULATIONS FOR THE CANDIDATES WHO HAVE
CROSSED DOUBLE THE DURATION OF COURSE OF
STUDY AND DISCHARGED FROM THE COURSE.**

The candidates, who have completed double the duration of the respective course and who are in 2nd year, 3rd year and final year course of study, will be given the balance duration of the course of study and grace period of one more year, to complete their course of study.

For example, the duration of the course for MBBS, is 5 ½ years. If the candidate completed the 2nd year and at the time of entering into 3rd year, he had a break of study exceeding double the duration of the course, he / she can continue the course for the balance course period of 3 ½ years and a grace period of one more year to complete the entire course. The period of study cannot be extended beyond the extended period (balance course period + 1 year Grace period)

The candidates will not be allowed to continue the course beyond the extended period in this scheme for any reason such as marriage or maternity. For any other medical grounds, the candidate should satisfy the Medical Board of this university and based on their report the university will take decision from case to case.

The candidate should submit their application to the University after obtaining necessary endorsement from the concerned institutions on or before 30th June 2012 for August 2012 UG examination before 5.00p.m. with course - wise fees.

If the candidate has not submitted the application with necessary endorsement, his/her application will be summarily rejected.

All the candidates who have crossed the double the duration has to undergo the course under prevailing Regulations and Syllabus framed by the university of the concerned course of study.

POST GRADUATE COURSES

The Post Graduate Degree / Diploma students who have not passed their examination and crossed Double the Duration of period of course of study are permitted to complete their university examination within a period of 1 year + 1 year grace period totaling to 2 years, failing which the candidate will be discharged from the concerned course of study.

The candidate should submit their application to the University after obtaining necessary endorsement from the concerned institutions on or before 28th February 2012 for April 2012 PG examination before 5.00 p.m with course-wise fees.

If the candidate has not submitted the application with necessary endorsement, his/her application will be summarily rejected.

The Post Graduate candidates will not be permitted to appear for the university examination beyond the extended period in this scheme, if they mention the reasons such as maternity. Any other medical grounds, the candidate should satisfy the Medical Board to be constituted by this university and based on their report the university will take decision from case to case.

The Post Graduate Degree/Diploma students will take up the university examination in April 2012 as per the prevailing Examination Regulations in theory & Practical framed by the university.

The UG/PG candidates those who have not crossed the double the duration of the course till the end of academic year April 2012 for PG and August 2012 for UG, need not apply in this scheme. They can apply for condonation of break of study through the institution to this university and get the condonation orders from the University to continue the course. If any dispute arises between the students and respective Institutions for completing the course, the University is in no way responsible for settling the dispute.
